- 2. Interested parties may collect tender documents from the Institute's office from 20<sup>th</sup> June to 10<sup>th</sup> July 2019 between 9.30 AM and 5.00 P.M. on working days by paying tender fee of Rs.100/- (Rupees one hundred only). For downloaded tender paper, no tender paper is required.
- 3. Sealed tender in the prescribed format along with complete documentary proof of experience should reach the office of the undersigned **on or before 11th July 2019** up to 3.00 PM. The tenders will be opened on the same day at 3.30 PM in presence of the bidders.
- 4. The sealed tender should be submitted along with Earnest Money Deposit of **Rs.15,000/**-(Rupees fifteen thousand only). The EMD to be paid **by Demand Draft in favour of NIRD-NERC, Guwahati**.
- 5. The following documents are to be submitted along with the tender:
  - i) Firm registration certificate;
  - ii) GST registration certificate;

  - e) <u>Mileage charges will not be claimed for the distance between the office of the party and the NIRDPR-NERC or the place of reporting.</u>
