- 1. The sealed quotations will be accepted up to 3.00 pm on 14-06-2017. The technical bids (Part-I) will be opened at 3.30 pm on the same day in the presence of those bidders or their authorized representatives, present. After thorough scrutiny of the details in Part I, the financial bids i.e. Part II of those firms who are qualified will be opened in the presence of those bidders who may choose to attend after due intimation to those who are qualified and the tenders will be finalized thereafter.
- 2. Incomplete bids and bids received after due date and time will be liable for rejection.
- 3. The bidder should enclose Demand Draft for Rs.5,700/- (Rupees five thousand seven hundred only) in favour of "NIRD-NERC, GUWAHATI", with the bid document towards EMD. The EMD will not carry any interest whatsoever.
